

The origin of all political expenditures, in the Commonwealth of Massachusetts, for any federal, state, county, or municipal election along with any ballot question, referendum, Amendment ratification, law or issue of which legislation had been filed in the previous or current session, shall be disclosed in a way for the public to have easy access so as to be informed of any involvement of foreign nationals in any of our political processes.

Any political expenditure by any foreign national shall be considered toxic. This shall result in a disclaimer provided by the Office of Campaign and Political Finance(OCPF) being attached to political communications by said entity. There will be three different levels of participation and three different disclaimers.

If it is determined that a foreign national has funded an entity it will be considered toxic and if with contributions, donations or in-kind expenditures result in over 50% of its funding and for any political communication put forth, by said entity, the OCPF shall provide a disclaimer stating that a foreign national has provided the majority of the funds for this communication.

If it is determined that a foreign national has made any contributions, donations or in-kind expenditures to an entity it will be considered toxic and for any political communication put forth, by said entity, the OCPF shall provide a disclaimer stating that a foreign national has partially provided the funds for this communication.

If any entity does not disclose the origin of all of its contributions, donations or in-kind expenditures, it will be determined that a foreign entity is most likely participating and the entity shall be considered toxic and the OCPF shall provide a disclaimer stating that a foreign national has most likely partially provided the funds for this communication.

The disclaimers will be added to the beginning of any TV or video ad, in a full screen, written in an obviously legible font and with an audio statement of the same. For radio, or audio ads, the OCPF shall provide an

oral statement of the disclosure to be played at the beginning of the communication. For any printed communications, including billboards or like situations, the disclaimer will be clearly visible in the same size font as the main message.

Any entity that has been designated as toxic shall have the disclaimer attached to their communications for at least a two year period or until the reason for their being designated as toxic is removed from their books.

Any entity that while under investigation, or having been designated as being toxic, shall cause same designation to be applied to any entity that it makes any contribution, donation or in-kind expenditure to, being subject to the same minimum two year disclaimer on their communications or until the reason for their being designated toxic is removed from their books, and so on...

Foreign national - Any government, agency, or department of a foreign country, any foreign political party, any foreign association, any foreign partnership, any corporation/ business which has its main office in a foreign country or is registered in a foreign country, any individual who is not a United States citizen or a legal permanent resident, or any corporation/ organization/ or association that has any non - U.S. resident or legal permanent resident as an officer or on its board of directors, or if 10% or more of its shareholders or members are not U.S. citizens or legal permanent residents.

Entity - Any artificial person, association, business, business league, cooperative, corporate entity, corporation, group, group of persons, labor union, limited liability company, limited liability partnership, non profit, not for profit, organization, political committee, political party, trade association or like terms.

Individual - Any reference to a citizen, inhabitant, man, person, subject, woman or like terms.

Artificial person - legal definition of a corporation.
