

ARTICLE 10: VOTED BY A MAJORITY – PASSED that the Town *raise and appropriate* \$4,300.00 to place the Assessors maps and data information on the Town's website.

ARTICLE 11: MOTION MADE AND SECONDED: I move that the Town of Warren call upon the United States Congress to pass and send to the states for ratification a constitutional amendment to reverse *Citizen united vs. Federal Election Commission*. The intent of this motion is to have the Town of Warren show its support for this amendment that will help restore constitutional rights and fair elections for the people, preventing corporations from using their enormous financial resources to inundate our political system and drown out the will and voices of ordinary citizens.

After a brief discussion the following vote was taken:

ARTICLE 11: CONSTITUTIONAL AMENDMENT
VOTED BY A MAJORITY – PASSED

ARTICLE 12: I move to amend the Warren Zoning By-Law by adding a new Section 14, Major Development as set forth in the handout provided at Town Meeting and attached to this motion.

MOTION MADE AND SECONDED TO PASS OVER ARTICLE 12 – MOTION PASSED

Just seconds after the article was voted to pass over resident, Mr. James Robitaille, asked if he could question this. Moderator said if you have a point of order, you can ask. The gentlemen said he had no idea what a point of order meant. The moderator explained the procedure. At this time the following motion was made.

MOTION MADE AND SECONDED TO RECONSIDER PASSING OVER ARTICLE 12
MOTION TO RECONSIDER – DEFEATED

ARTICLE 13: VOTED BY A MAJORITY (ONE OPPOSED) that the Town *transfer* \$50,000.00 from the Stabilization Special Use Equipment Account to purchase a truck for the Highway Department.

(2/3'S VOTE)

ARTICLE 14: VOTED BY A MAJORITY (ONE OPPOSED) that the Town *transfer* \$54,000.00 from the Stabilization Special Use Equipment Account and *transfer* \$26,000.00 from the Highway Equipment Rental Account to purchase a used dump truck for the Highway Department.

(2/3'S VOTE)

ARTICLE 15: VOTED BY A MAJORITY – PASSED that the Town *raise and appropriate* \$7,000.00 to replace a fire hose for a fire apparatus.

ARTICLE 16: VOTED BY A MAJORITY – PASSED that the Town *raise and appropriate* \$2,500.00 to purchase supplies and equipment for the Town's community baseball, softball, basketball, soccer, and football programs.

ARTICLE 17: VOTED BY A MAJORITY – PASSED that the Town authorize the Board of Health to employ a member of said Board to provide secretarial services during Fiscal Year 2013 and to authorize payment from the Board of Health Secretary Account at a rate of \$10.00 per hour.

ARTICLE 18: VOTED BY A MAJORITY – PASSED that the Town authorize the Tree Warden and Deputy Tree Warden to be compensated from the Forestry Expense Account for emergency tree work at a rate of \$20.00 per hour, not to exceed \$1,200.00 during Fiscal Year 2013.
